Terms and Conditions

These terms and conditions pertain to all the staging programs conducted by CSP International Business Training Academy, Certified Staging Professionals® and Canadian Staging Professionals®, under the incorporation of Decorating Solutions Inc. (Niagara).

Payment and course fee

Full course fee is required prior to attending any course. Course fees include instructional training, course materials, 1 year membership on directory and light refreshments. Course fees do not include meals, accommodation or transportation.

Cancellations

As with all learning institutions, refunds are not sanctioned for any circumstance. DSI and CSPI will accommodate certain transfers and date rearrangements in the event life, death or illness makes it impossible for you to attend after registration, however a nominal administration fee will apply as below.

Refunds will not be granted unless the cancellation decision has been made by Decorating Solutions (Niagara) Inc. In these circumstances the applicant will have the choice to transfer to another course location/date or receive a complete refund. Refunds will be made back to the payee via original method of payment.

Rescheduling

We often make commitments with a hotels one month in advance. You may however, reschedule at no charge up to three weeks before your scheduled class date. If you reschedule two weeks prior to the class date there will be a \$100 administrative fee assessed. Anything less than 2 weeks will be a \$200 rescheduling fee.
